# **Quaker Quest Workshop November 13, 2010**



Providence Meeting will be holding a Quaker Quest workshop for members and attenders at the Providence Meetinghouse from 9:00 AM to 4:00 PM on Saturday November 13. The workshop will be led by two facilitators provided by Friends General Conference and will include breakfast (light) and lunch. The success of the workshop will depend on our having a high level of participation, so please save the date, November 13, on your calendars.

Quaker Quest was founded on the conviction that Friends have a spiritual path for today that is simple, radical, and contemporary, and that the stillness that is at the core of Quaker worship is as needed today as ever, along with the spiritual and social values we have derived from it. The first step is a workshop for Meeting members and attenders, and other meetings have found that this can be a transformative form of inreach for a meeting.

Through this process, the meeting community is invited to consider what it is like to be a newcomer and to develop ways to integrate newcomers into the life of the meeting. The community is also asked to consider what forms of spiritual hospitality are already in place and what they might want to change or add. At some point after the workshop we may decide to go ahead with public sessions, the aim being to encourage Friends to clarify and speak of their faith experience and help others find out about the Quaker way of life, based on the observation that people enquiring about us want to experience Quaker worship, hear why being a Quaker matters to us, talk to each other and us about it, and get an idea what sort of people we are.

### Providence Monthly Meeting for Business Minutes- Tenth Month 14th

### Providence Monthly Meeting of Friends Tenth month 14th, 2010 - Minutes of monthly meeting for business.

1. Friends gathered at the Saylesville Meetinghouse at 7:10 pm following a potluck supper, with fourteen Friends present.

2. In the opening worship, the clerk read an Advice on Outreach from the proposed Faith & Practice of Baltimore Yearly Meeting (2009):

Outreach ...includes being open to others who may be tentatively 'reaching in' to explore the Quaker faith. The sense of welcome is expressed in countless small details: the coffee is warm, the biscuits are good, the potluck is plentiful, and people say 'hi'. Most importantly, when someone walks in and asks, 'What do Quakers believe?' it is the meeting's task to be sure that they are likely to get a well-informed answer from anyone they might approach.

#### 3. Announcements:

Rhode Island-Smithfield Quarterly Meeting will be 17 of Tenth Month at Voluntown (CT) Peace Farm, hosted by Westerly Monthly Meeting.Joyce Aljouny, Director of the Friends School in Ramallah, Palestine, will be speaking at Providence Meetinghouse after a special potluck following meeting for worship on the 31st of this month. All are invited.

Providence Monthly Meeting's day-long retreat for Quaker Quest will be 13 Eleventh Month beginning at 9 am. Friends interested in assisting in this special event should contact Dan Lederer for opportunities to volunteer.

The transfer of membership for William ("Tad") Manning Jose Jr. to the Alexandria (VA) Monthly Meeting of Friends has been completed with that meeting's acknowledgment.

The Peace and Social Concerns Committee will host a showing of the film "At the River I Stand," on Martin Luther King's final campaign in Memphis, at the meetinghouse, on October 22 at 7 pm.

4. Pastoral Care: Ministry & Counsel recommends adding Phebe Howland as a member of the Pastoral Care Committee. Friends approved.

5. Finance Committee: For the Finance Committee, Bruce Carlsten presented a revised guideline for contracts entered into by the meeting or its committees. The finance committee has addressed concerns raised in the business meeting's past consideration of this issue in 6th month 2010.

After an opportunity for questions and comments, Friends approved these guidelines as a working document.

### ----- Guidelines for Contracts -----

1. Routine or periodic contracts (i.e. servicing the boiler, exterminator, etc.) within the committee's budget may be signed by the clerk of the initiating committee, up to a maximum of \$10,000. Amounts above \$10,000 require the signature of the Presiding Clerk.

2. All contracts not covered by the initiating committee's existing budget (and therefore requiring additional funding) must be approved by the Providence Monthly Meeting for Business.

3. All contracts over \$1,000 shall have a written contract, and shall be reviewed by the Finance Committee. The initiating committee, as part of its due diligence, is responsible for seeing that service providers have appropriate insurance for liability and workers' compensation.

4. Non-routine/non-periodic contracts for more than \$1,000 shall be presented by the initiating committee at a business meeting for the information of the membership. At the discretion of the clerk of Providence MM and/or on recommendation of the Finance Committee, the business meeting may be asked to give formal approval. Change orders or addenda shall go through the same procedure.

5. Except for routine expenditures described above, all contracts committing Meeting funds shall be signed by the presiding clerk of the meeting or his/her designee.

6. In a bona fide emergency, the responsible committee may take emergency action to protect life and property, and shall consult with the presiding clerk and the clerk of the Finance Committee as soon as feasible.

### 6. Ministry and Counsel minute on FUM:

On behalf of Ministry and Counsel, Dan Lederer presented a proposed policy minute concerning funding for Friends United Meeting, as requested by New England Yearly Meeting, arising out of a concern about FUM's personnel policy as it affects applicants or employees who are in sexual relationships other than a ceremonial heterosexual marriage. Ministry and Counsel has been working on this question for a year, including wide consultation within the monthly meeting.

Friends noted that this minute is consistent with the actions taken by New England Yearly Meeting for the past two years, which allow monthly meetings to engage in "negative earmarking" to reduce or eliminate having that meeting's contribution to yearly meeting go to Friends United Meeting. The purpose of this minute is to allow contributions to

Providence Monthly Meeting (and through it, to New England Yearly Meeting) by Friends who object for reasons of conscience to having their money go even indirectly to FUM. Whether this is an effective or necessary witness is up to each individual. It does not respond fully to the concerns of those Friends who feel an urgency about pushing Friends United Meeting to alter its personnel policy. It was suggested that the meeting discern at a later time whether FUM should remain in the monthly meeting budget, although this would not eliminate contributions through New England Yearly Meeting. Ministry and Counsel also has not looked at the personnel policies of other organizations to which we contribute.

In approving the monthly meeting budget, we respect and trust the process of formulating the budget, even if each of us may not wholeheartedly support every line item in it. Dan pointed out that the total in the Providence Monthly Meeting budget for the current year that goes to Friends United Meeting is \$455, of which \$100 is a direct donation and \$355 is the portion of our donation to NEYM that goes from NEYM to FUM. This is 0.57% of the monthly meeting budget.

Under this proposal, if a person informs the Treasurer that he or she wishes to utilize the procedure in this minute, the Treasurer will subtract the designated percentage from the amount that would otherwise be sent to FUM, and will transfer that amount to a restricted fund for disposition by the meeting. A number of Friends asked that FUM be notified of the reason for any reduction in amount, such as by sending them a copy of our minute to accompany our check. It was noted that Friends who wish to support the ministries of FUM, such as peace-making work in Kenya, may do so directly to FUM.

After an extended consideration, we approved this policy, with one Friend standing aside. We ask Ministry and Counsel to continue to discern on the larger question of our relationship with Friends United Meeting, as the minute indicates. We would also like to see programs educating members of our meeting about all the national and international Quaker organizations that we participate in through New England Yearly Meeting.

#### Minute on Friends United Meeting

Providence Monthly Meeting honors committed relationships regardless of gender. We affirm this Truth as we reach out in our connections to the wider Quaker community. We hold steady to our commitment while acknowledging that all Friends do not share the same Truth in this matter.

Friends United Meeting is deeply engaged in discernment regarding the divergence of leadings around marriage and committed relationships in response to concerns among their affiliated yearly and monthly meetings regarding their personnel policy, which requires that all applicants agree to confine sexual relations to marriage between a man and a woman. We support many of the valuable works of FUM, but, because of this policy, some of our members feel called to withhold their financial support to FUM at this time.

At this point, Providence Monthly Meeting has decided to give members and attenders the option of withholding the portion of their contributions that would normally go to FUM and will instead redirect it to a dedicated fund for future charitable use. In the meantime, we will continue seeking greater unity within our meeting in response to FUM's policy.

7. Smith bequest: The Finance Committee wishes to remind Friends that about \$8,100 of the Smith bequest remains available for special activities or purchases that will enhance the life of the meeting, and the Finance Committee would be happy to see the fund expended. (See minutes of 11th month 2007.) It has been suggested that some of this money be used to purchase bulk copies of the FGC Worship in Song hymnal. We authorize the purchase of up to 50 large print hymnals, to be shared among our local meetings for worship, and ask an ad hoc committee consisting of the clerk, recording clerk, and John Lord, to make the final decision. We ask other committees to consider other possible uses for the remaining money and bring them to Finance Committee by the end of this calendar year.

8. Treasurer's Report: Treasurer Peter Swaszek presented an interim report on the first one-third of the fiscal year, covering the period from 6th mo. 1, 2010 to 9th mo. 30, 2010. He noted that individual contributions are about \$1,000 ahead of the same period in the prior year. Expenses have been close to what was anticipated. We accept this report with gratitude.

9. Property committee: Bob Elliott reported that a crew will be working on the siding on the east wall of Saylesville meetinghouse over the next few weeks.

10. Saylesville Preparative Meeting: Joanne Griffin observed that donations for the book swap have increased, including more books for children and teenagers, along with the number of people participating each time. Habitat for Humanity has been taking 100 to 120 books each month for fundraising and distribution overseas. The meeting looks at this activity as a public value tool to support future fundraising and grant applications. There will be an article in the meeting newsletter highlighting the book swap.

11. We closed at about 9:20 pm after a period of grateful worship, intending to meet again on the 14th of 11th month at 12:15 pm at the Providence Meetinghouse.

### Rachmaninoff All Night Vigil (Vespers) concert

Nov. 6 & 7 - The Brown University Chorus will perform Rachmaninoff's *All Night Vigil* (Vespers), based on Russian Orthodox Church chants and sung in Old Church Slavonic (one of our singers is a Russian teacher). Unlike the heavy post-romantic pieces Rachmaninoff is best known for, I have found this to be one of very few 20th Century religious pieces that is clearly 20th Century sounding (though completely tonal), while feeling completely respectful of spirit, and filled with the sense of holiness that inspired the original chants. Many of its most powerful sections are moments of delicate and extremely quiet sounds, about as close to 'In the light' as you can get with just sounds.

GRANTS

1) All grant applications for meeting activities and projects shall come through a standing committee and be presented to Business Meeting for its consideration.

2) Approved grant applications must be signed by the Providence Monthly

Meeting's clerk or designee.

Joyce Aljouny, Director of the Ramallah Friends School, will be speaking at the Providence Meetinghouse after Meeting for Worship on First Day, October 31. Ramallah Friends School was founded in 1869 and is currently operated by Friends United Meeting. Joyce will speak about the important impact that the school has had on the community during its 140 year history as a leading school in the Middle East, and describe her personal challenges along with those she shares with the school's students and teachers as a result of living and working under a military occupation. Please join us for this unique opportunity to meet Joyce.



Joyce is a member of the Ramallah Monthly Meeting and is one of the very few Palestinian Quakers left in the country. Joyce is a graduate of RFS and also a mother of three boys (see photo above), two of which attend the school and a third who is an alumnus. Her job involves oversight of both the lower and upper school campuses. This includes ensuring the rigorous academic program develops to meet the modern day challenges, fundraising, infrastructure development, community building and financial administration.

Joyce will speak about the important impact that the RFS has had on the community throughout its 140 year history as a leading school in the Middle East. She will also describe her personal challenges, as well as those of the RFS community of students and teachers, that result from living and working under a military occupation. Donations to the School and to Joyce's work and ministry are welcomed.
