

Providence Monthly Meeting for Business Minutes – 8 First Month 2012

The meeting convened at 12:20 pm at the Providence Meetinghouse with twelve Friends present. In the opening worship, the clerk read the following queries from Faith and Practice of NEYM, 1985:

Are meetings for business held in a spirit of worship and prayerful search for the way of Truth? Are all members encouraged to use their talents in the service of the meeting? Do you undertake your proper share of the work and financial support of the meeting?

1. Announcements:

There have been two book donations, the first a copy of Australia Yearly Meeting's "Faith and Practice" given to us by two Friends from Friends World Committee for Consultation (FWCC), the second "A Quaker Cupboard" from Westerly Monthly Meeting.

There will be a NEYM Mid-Year Gathering this March, organized by Sessions Committee and the Young Adult Friends Climate Change Working Group. It will be held at St. Andrew's Episcopal Church in Wellesley, MA on Saturday, March 31, 8:30 AM to 8:00 PM. Check "neym.org/midyear" for online registration information on February 1. There will be a \$25 charge per adult and no charge for children. Overnight hospitality with area Friends will be available upon request.

A worship group will be meeting at Saylesville on Wednesdays, the starting date to be determined.

- 2. Friends approved Dave McNab's appointment as representative to the Faith and Order Committee of the RI State Council of Churches.
- 3. For Ministry and Counsel, Bob Elliott presented a proposal that Ministry and Counsel's Building Use Subcommittee be laid down and that Program Committee's responsibilities be expanded to include: determining whether a proposed activity is in keeping with our guidelines or has such merit that an exception to the guidelines can be made; deciding on an appropriate donation from the requesting group; when needed, assisting with the preparation of a contract; when there are further questions regarding any of the above details, or when the committee is not in unity regarding a request that has been referred to it, referring the request to Ministry and Counsel for further discernment; and proposing any necessary changes to Meeting's existing guidelines for meetinghouse use.

Friends expressed a variety of concerns about child protection, liability, insurance, heating and other maintenance issues, the fact that Program Committee's mission has been to organize programs within Meeting rather than the above duties, and the lack of representation by Property and Finance committees.

The sense of the Meeting was to establish an ad hoc Building Use Committee on a temporary basis, its charge being to draw up revised meetinghouse use guidelines that address the issues of child protection, liability, finance, maintenance, and whether a standard contract is necessary for outside organizations as well as how such a contract will be monitored. The committee was also asked to make a proposal regarding which committee will assume its responsibilities in the future. Friends approved appointing Bruce Downing to represent Finance Committee, Bruce Carlsten to represent Property Committee, and Betsy Zimmerman to represent Program Committee. All three Friends are members of Ministry and Counsel. Friends recommended that the committee consult with someone with experience in writing contracts, and Friends asked that an initial report be submitted to Meeting for Business no later than our June 2012 meeting. Finally, Friends approved laying the committee down after a final report is accepted.

4. For Property Committee, Bob Elliott reported that the committee is entertaining suggestions regarding a stairlift.

We closed at about 2:00 PM following a period of grateful silence, intending to meet again, God willing, on 12 second month 2012.



Clerk's Corner by Mark Conley

Coming home after Business Meeting this month, I realized that I had forgotten to announce the worship sharing for our annual State of Society report. The worship will be on the 22nd of this month at 11:30 at the Providence Meetinghouse.

The State of Society report is an opportunity to reflect on how we have been, what we have done and how we have worshipped in the past calendar year. This month's worship sharing is the first step in this process of reflection. When we meet, one Friend clerks and another records the messages that come to us in our worship. Sometimes committees also contribute written statements regarding their work. Saylesville sends a report as well.

A member of Ministry and Counsel then writes a preliminary draft State of Society Report and presents it to the entire committee at its meeting next month. The committee discerns what revisions and additions might need to be made, and usually the report goes back for a few changes and comes back to Ministry and Counsel the month following (March). If it meets with approval, the committee forwards the suggested report to Meeting for Business, where it once again winnowed (although one year Meeting saw fit to accept it after its first reading!). Usually it gets one more set of suggested revisions, with approval generally occurring in April.

At that point, it has served the Meeting well, because we have been reminded of our concerns, accomplishments and hopes from the past year even as we are well underway in the new one! But our report's work in the world isn't finished. We forward our report to our Quarterly Meeting, where it is read to all present along with the reports from Smithfield, Westerly and Worcester. If you have a chance to attend Quarter, this is an interesting one to attend if you like learning about our Friends nearby. All our reports are then forwarded to New England Yearly Meeting, where that body's Ministry and Counsel draws up a state of society report for the entire yearly meeting, drawing its information and discerning trends and currents of thought from among the reports it got from the individual meetings.

Whew! And all that starts with one worship-sharing session! I hope you'll join us this bright new year as we consider as a society what the old year has to teach us.

And as always, thank you for everything you do in the Life of our Meeting.


