Sixth World Conference of Friends (adapted from Betsy Cazden)

Betsy Cazden, along with about twenty other New England Friends, will be attending the Sixth World Conference of Friends, in Nakuru, Kenya, from April 17 to 25. Friends World Committee for Consultation organizes world-wide conferences about once a generation, and this will be the largest such gathering since the 1967 conference at Guilford College with about 1,000 participants. The conference theme, which draws on Matt. 5:13-16 as well as John Woolman and other Biblical texts, is "Being Salt and Light: Friends living the Kingdom of God in a broken world." Friends who are not traveling to Kenya can participate in and learn from this event in other ways:

Providence Monthly Meeting for Business Minutes – 8 Fourth Month 2012

1. The meeting opened at 11:50 am at Providence, with sixteen Friends present. In the opening worship, the clerk read queries on personal conduct from New England Yearly Meeting's *Faith and Practice* (1985):

Do you live with simplicity, moderation, and integrity?

Are you punctual in keeping promises, careful in speech, just and compassionate in all your dealings with others? Do you take care that your spiritual growth is not sacrificed to busyness but instead integrates your life's activities? Are your recreations consistent with Quaker values; do they refresh your spirit and renew your body and mind?

2. Announcements:

Rhode Island – Smithfield Quarterly Meeting will be held at Westerly on the 15th of 4th month. In addition to regular business, the program will include discussion of the upcoming Friends General Conference Gathering at URI this Summer. All are welcome.

On Saturday, 14th of 4th month, at 5:30 pm, AFSC will host a Potluck and Racial Profiling Program at Providence Meetinghouse. The youth of the Providence Youth Student Movement will talk about their experiences as Asian youth on the streets of Providence and about the legislation they (and AFSC) have been working to get passed. Suggested donation of \$25 to support the work of AFSC and PRYSM.

Next month will be our last Meeting for Worship with a Concern for Business at Providence Meetinghouse until fall. In keeping with recent custom, we will hold our Meeting on 10 Fifth Month, with a 6 p.m. potluck and 7 p.m. Meeting.

The meal that AFSC and this meeting agreed to serve at the statehouse will be on Wednesday, 11th of 4th month. Volunteers are still needed to help prepare food the night before and to serve that afternoon.

3. Statistical Report for 2011: Meeting Recorder Anne DiMase presented the statistical report as of the end of 2011, using the format provided by New England Yearly Meeting. The total membership at the end of the year was 180 at Providence, 12 at Conanicut, and 21 at Saylesville, for a total of 213. In addition, we have about 40 active non-members. Average attendance at worship has been 69 at Providence, 7 at Conanicut, and 6 at Saylesville. Friends asked that the complete report, or a written account of it, be made available in the newsletter.

The recorder also reported that Nano Rush has asked that her membership be discontinued. Friends approved, with regret.

- 4. For Nominating Committee, Elsie Morse presented a proposed list of appointments to meeting committees for the coming year. The committee does not have new names for Finance or Religious Education, and would welcome volunteers or suggestions. Friends approve this report, with permission to add names if the committee has some at future meetings. We thank the Nominating Committee for its work, recognizing the valuable role the nominating process can serve in drawing out gifts, talents, and interests of the members of our meeting community. We may wish to examine the process and timing of forming the Nominating Committee, and refer this to Ministry and Counsel for further seasoning.
- 5. Welcoming statement for website: For Ministry and Counsel, Dan Lederer presented a follow-up to our previous minute concerning the meeting's listing by the Institute for Welcoming Resources as a religious organization that is welcoming to the gay-lesbian-bisexual-transgender (GLBT) community. (2d mo. 2012, Minute 9.) Ministry and Counsel proposes the following language to be placed on the meeting's website:

In keeping with our belief that there is that of God in every person, Providence Monthly Meeting welcomes all persons regardless of sexual orientation or gender identity, race or color, national or ethnic origin, sex, age, or disability.

We approve this language, and authorize Ministry and Counsel to disseminate it as appropriate.

6. Minute regarding FUM personnel policy: Ministry and Counsel also brought a proposed minute concerning the restrictive personnel policy of Friends United Meeting:

It saddens us and causes deep hurt in our community that FUM has a stated hiring policy that explicitly fails to recognize loving relationships that have been blessed, acknowledged and embraced by our community of deep faith, and has therefore rejected the contributions, and indeed the basic humanity, of many, both in our community and in the larger worldwide community of Friends, with a policy that openly discriminates against individuals and families based only on their sexual orientation, and not on the quality of contribution that they may be able to bring to our collective spiritual work.

We urge FUM to reconsider this policy, and to give the same loving care and consideration in employment to all couples and individuals, regardless of their gender or sexual orientation.

We note that this minute does not address the question of employment of persons in intimate relationships outside of marriage. Some Friends requested that this be added to the minute, to reflect the current reality of many of our lives and honor that of God in each person. Concerns were expressed about broadening the minute. One Friend noted that acceptance of intimacy without regard to marriage is a significant and fairly recent departure from traditional Quaker practice, which most Friends in the world continue to uphold. We also note the complexity of making hiring decisions in a global multicultural context, especially for positions outside of the applicant's home country.

We were also reminded that the FUM General Board itself is in flux on this question, and that it is not clear what effect our minute would have either on deliberations of New England Yearly Meeting or on FUM.

We thank Ministry and Counsel for furthering this fruitful conversation, and ask that it continue threshing this question and when appropriate to bring back a revised minute for our consideration.

7. Budget: For the Finance Committee, Bill Monroe presented an initial proposed budget for the fiscal year beginning Sixth Month 2012. About one-third of our total budget goes to maintain our buildings and properties; one-third, as contributions to New England Yearly Meeting and other causes; and the remainder for our activities. He noted significant new requests of \$3,000 to provide a stipend for the person working with the high school students, a discretionary fund under the control of Saylesville Preparative Meeting, and small increases in our donations to Providence and Lincoln governments. The Finance Committee also recommends increases in the contributions for maintenance reserves for our properties. The proposal before us would require a substantial increase in contributions from members, and the committee welcomes comments on whether this is acceptable. It reflects both increased activity within the meeting and prudent stewardship of our assets.

Several Friends noted the usefulness of having guidance on what the average contribution should be, while recognizing that Friends need to give according to their own circumstances and leadings. The Finance Committee intends to do this periodically during the year, in part to encourage Friends to make donations through the year.

We look forward to hearing a second reading of the budget at our next meeting.

8. Nomination of Assistant Clerk: The Clerk noted that he has served five years as clerk, and looks forward to relinquishing that responsibility. According to our custom, Ministry and Counsel presents the name of Dan Lederer to serve as Assistant Clerk of the meeting, with the expectation that he may be available to assume the clerkship in the future. This would require appointment of a new clerk for Ministry and Counsel.

We approve this appointment.

- 9. Religious Education report: It was reported that the Religious Education Committee has been looking for a back-up person to work with the high school students as needed.
- 10. We concluded at about 2:10 with a period of grateful silence.

Thanks and notes from Ben Brown concerning Women's Rights issue

Thanks to everyone who stood up against the mandatory ultrasound bill which came before the Rhode Island House Judiciary Committee recently. For those who didn't hear about this issue at the time, House Bill 7205 would have required that all women presenting for an abortion have an ultrasound prior to the procedure, and that they have the internal and external organs of the fetus described to them - regardless of whether they wished to hear that description or not. Under this law, physicians would have been given the option of either verbally shaming patients for their choices - destroying the trust inherent to the doctor-patient relationship in the process - or receiving up to a \$250,000 fine for non-compliance. This and six other pieces of restrictive legislation were all tabled by the committee, which represents a big victory for women. Live From Kenya – Update and Request For Prayer

Dear friends,

I have been asked to clerk one of the plenary sessions here at the World Conference -- 900 people in a huge auditorium, threshing minutes on political or policy topics. It's daunting. The timing is that you will be meeting in worship Sunday while we are in that business session -- it begins at 4:15 here, 9:15 am there, and runs until 6:15 pm here, 11:15 there. So I am hoping perhaps a few people could hold us in prayer as we meet. There is a pastoral care team here that will have three people on the platform for that purpose as well, and possibly a few more, but I also wanted to give Providence Friends an opportunity.

Things are going very well here. My flights got a bit scrambled but the efficient Swiss customer service person managed to get my luggage rerouted with me. On Monday we came by bus from Nairobi up the Rift Valley about four hours to the campus. It is lovely weather until about 4 pm each day when it rains hard. My "home group" (like the "anchor groups" at NEYM) has about 17 people from North America, Europe, and Africa, a good daily opportunity for personal sharing. Guidance for Friends Committee on National Legislation (FCNL) – from Zona Douthit

Every two years, FCNL asks for guidance from Friend's communities in setting their lobbying priorities in the next Congress. On March 25, thirteen Friends gathered for a threshing session to devise Providence Friends Meeting's suggestions. We have forwarded the following five items to FCNL for consideration.

- 1. War prevention, including population control, women's rights, water rights, sustainability.
- 2. **Promotion of social equity**, including fair taxation, immigration reform, marriage equality, protection of minorities and healthcare.
- Criminal justice reform, including ending the privatization of prisons for profit and rational gun and drug laws.
- 4. **Shifting military spending from military to social justice**, create incentives for corporations to turn swords into ploughshares. Universal public service for 18 year olds whether in the military or other public service organization. . Keep promises to veterans.
- 5. **Campaign finance reform**, including a constitutional amendment overturning *Citizens United* case.

Yearly Membership Report Summary

The following is a summary of the yearly report of the membership of the Providence Monthly Meeting of Friends. It is for the year which ended on December 31, 2011. This report is given at Business Meeting, and sent to the Quarterly Meeting and the New England Yearly Meeting.

The previous year, 2010, we had a reported total of 218 members. Additions for the year ending 2011 included 2 due to an error the previous year, 3 additions by application for membership in Providence, and one addition by Certification of Transfer in Conanicut.

Losses included 3 by death, 5 by discontinuance/resignation, and 3 by Certificate of Transfer to other Friends Meetings. This amounted to a net loss of 5 members.

The composition of the membership includes 106 males 107 females. We have 161 resident members and 52 non-resident members. 10 of our members are ages birth through 14; 9 are ages 15-18; 23 are 19-25; and 66 are age 65 or older.

Our average attendance in Providence is 69 people, 34 of whom are active attenders (non-members). In Conanicut, average attendance is 7 people, 4 of whom are attenders. In Saylesville it is 6 people, 2 of


