Providence Monthly Meeting for Business Minutes – 14 Fourth Month, 2013

- 1. We gathered at 12:00 at the Providence meetinghouse with fifteen Friends present. In the opening worship the clerk read the following queries, from *NEYM Faith and Practice* (revised, given preliminary approval 2012):
 - 1. Do I practice spiritual disciplines during the week to prepare my heart, mind, and spirit for corporate worship?
 - 2. Am I faithful and punctual in attendance at meeting for worship?
 - 3. What are my particular spiritual gifts and do I exercise them in meeting for worship?
 - 4. Has my understanding of worship and its possibilities deepened over time and nurtured my spiritual growth?

2. Announcements:

The AFSC-SENE Tenth Anniversary Celebration and Fundraiser will be at 6:00 PM on Friday April 19 at the Providence Meetinghouse.

Rhode Island/Smithfield Quarterly Meeting will take place at the Smithfield Meetinghouse on April 21. Worship is at 10:30, followed by lunch and program. All are welcome.

3. Marriage Clearness Proposal: Erin Hazlett, clerk of the Marriage Clearness committee, reported that the committee received a request for marriage from John Gaffney, a long-time member of this meeting, and Dale William ("Bill") Brown. They are currently living in Florida and John has some health issues that make it difficult to travel. They have been together as a couple for 33 years but have never had a public commitment ceremony. They plan to have a civil marriage in Massachusetts on June 14, 2013, and request a wedding under the care of Providence Meeting on June 15, 2013. The Marriage Clearness committee has talked with them extensively by telephone and recommends that the meeting take oversight of this marriage.

Consistent with this meeting's minute of 11th month 2006, we approve this request and appoint a special meeting for worship for this purpose on June 15, 2013, at a time convenient to the couple and the meeting calendar. We ask the marriage clearness committee to name an oversight committee, after consultation with the couple.

- 4. Nominating Committee: Ruth Bourns, clerk of the Nominating Committee, presented a proposed list of people to serve the meeting for the year beginning June 1, 2013. We approve the nominations as presented and thank the Nominating Committee for their careful work on this matter.
- 5. Proposed 2013-14 Budget: For the Finance Committee, Peter Swaszek presented a Proposed Budget for 2013-2014, together with colored graphs illustrating the meeting's spending, income, and fund status over the past eight years. He noted that the current year budget depended on a significant increase in contributions, which has not been fully realized. He projects that we will finish the year at the end of May with a deficit of just under \$7,000. He views this as consistent with normal year-to-year fluctuations.

This proposal would require increased contributions from members in an amount even greater than the current year. Some find this overly optimistic. The largest increases in the proposed budget are for nursery care and the high school program. Although some meetings rely on volunteers, we have found it useful to pay workers in order to have a reliable and robust program for both age groups. The Finance Committee would welcome additional suggestions from members on how to bring expenses and income better into balance with a more realistic figure for contributions. We ask the Finance Committee to consult with committees to see if their requests could be reduced. We look forward to seeing a revised budget (or several alternative budgets) at our next meeting.

6. Saylesville: For Saylesville Preparative Meeting, Joanne Griffin reported that they have changed the schedule of their preparative meeting for business in order to be able to get to Providence earlier for monthly meeting. She noted that they are currently completing the final phase of work on the first floor of the east wall, namely installing bookcases. The ceiling has also been replastered. The second floor still requires some work, and the interior storm windows need to be installed.

An anonymous donor has agreed to provide materials to construct a wheelchair ramp into the meetinghouse. The meeting still needs to research design options and whether this construction will require permission from the local historic preservation commission.

Joanne listed several upcoming events, including book swaps, a music program, a craft fair, and a program on Quaker activities during the War of 1812. More details will be made available in the meeting newsletter.

- 7. Treasurer's Report: Peter Swaszek presented an interim report on the meeting's finances through the end of March 2013. He requested permission to overspend the line for high school program up to a total of \$3,700, which will exceed what he is authorized to pay out above the budget. While we see the value of this program, questions have been raised about how the compensation was set and why it is exceeding the budget. The meeting approved authorizing the Treasurer to pay bills incurred, but asked that there be a forthright conversation between the Finance Committee and the Religious Education Committee about the increasing spending for this item, with a report back to this meeting.
- 8. No further business appearing, we closed in grateful silence at 2:00, intending to meet next on May 12, at the Saylesville meetinghouse.

Thoughts On Our Behavior and the Environment –from Eugenia Marks

Our life-styles are leading to a condition of nature that will be difficult for us to adjust to. Collectively, nationally we need to vastly reduce the emissions that are leading to warmer ambient temperatures, more intense storms, sea-level rise, and other adverse climatological changes, things about which I am pessimistic.

At this season of year when we are lifted by the emergence of green and multi-colored beauty, we celebrate escape from oppression and the hope of new life. Let us use that buoyancy in whatever ways our intelligence, skills, and spirit lead us, collectively and individually, to pledge action against further increases in "greenhouse gases."

Ask discernment from Cynthia Giles, support efforts like Paul's, walk instead of driving where you are able, think Albie's electric car, eschew the use of small motors in household applications, write to state reps to support public transportation, write to federal delegations on various bills, offer solutions, think of alternatives to burning fuels and of more efficient use of fuels. Be aware of the sun's benefits.

Knowing how I fail, I seek greater awareness, discernment, and effectiveness in action.

I will always remember a message shared in worship one Sunday a long time ago that reflected with joy and thanks on an island retreat in Maine. An island removed from the hustle and bustle of everyday life. An island that the speaker returns to every year to find anew a deep and real sense of calm and repose. A place to go to be quiet and focused, inspired and refreshed, because there is on this island that special time and space that is removed from the everyday world. The message bearer remarked that those times and places where/when we are able to center down, and listen for the voice of the spirit within us, are so very precious. Their boundaries are fragile and need protection from incursions by the outside world that so insistently clamors for our attention.

That island in Maine seems to me a metaphor for our time together on Sunday mornings – a precious brief hour – a quiet room to gather as a community in waiting worship in that oasis of time and place in which we center ourselves. Where, in the calm and focus, we may find inspiration and refreshment in the presence of the Light.

Now, as a place removed from the world, the island has one obvious geographical feature in its favor. It is surrounded by water. To get there is to leave the mainland and worldly cares behind. In our Meeting House we do not have the same clear physical boundary. On Sunday mornings, we need to create a special place and time together. Each one of us, old and young, is a crucial participant in this creation!

And so these queries come to mind: Do we value that hour of worship time together enough to protect it from the incursions of the everyday world? How do we in our own individual ways honor the gathering as we join in and participate? Do we, each one of us, make sacred the hour - the full hour - when we worship together – preparing for and entering the Meeting House with anticipation, settling ourselves beforehand so that we are present and ready to fully create our centered worship together?

And when running late, as we all strive not to...but inevitably may sometimes do, do we nevertheless join quietly and unobtrusively into the gathered worship knowing that the Light we bring is joyfully welcomed and fully contributing?

In the spring of the year, I offer these thoughts with love and tender concern for all in our community!

CLERK'S CORNER by Dan Lederer

Proof of Heaven?

Eben Alexander III is an academic neurosurgeon who, in 2008 at age 54, developed bacterial meningitis and was in a coma for seven days. He is convinced that during this near death experience he found himself free of memory or bodily identity and yet somehow was able to maintain consciousness such that he became, by his own description, "a point of awareness". In this state he entered a divine realm where he felt himself close to and in fact surrounded by God.

Given the severity of his illness, his subsequent emergence from the coma and gradual recovery of complete neurological function was something of a medical miracle and a good story unto itself. But with an even more astounding tale to tell, he has taken on the mission of sharing his spiritual experience and detailing the effect it has had on him, accomplishing this via speaking engagements and a book entitled "Proof of Heaven: A Neurosurgeon's Journey into the Afterlife". Not surprisingly, there has been plenty of skeptical commentary about his book, but given the possibility that what he says is valid, we earth-bound seekers owe it to ourselves to examine his interpretations and conclusions, even if just out of curiosity. Here are some of them.

- On our connectedness to God and to each other: No physical particle in the universe is separate from any other, and God is present in every particle of the universe. God is present in us at all times, and we are connected to each other through this divine link with God. Every one of us is deeply known and cared for by our Creator.
- On our spiritual nature: We are cosmic beings, not limited to our physical bodies. We can get closer to this genuine spiritual self through prayer and meditation and by expressing love and compassion.
- On the role of consciousness: Consciousness is the basis of the physical world, "the deep mystery at the center of existence." Our own consciousness is a direct extension of the Divine rather than just the result of brain activity.
- On life here on earth: Without recovering the memory of our larger connectedness, and of the unconditional love of our Creator, we will always feel lost here on earth. Evil exists on earth but this is not evidence of the absence of God's love; rather, it's an inevitable result of our having free will.
- On the afterlife: The human experience extends beyond the grave. The death of the body and brain are not the end of human consciousness.

Is it possible to "prove" the existence of heaven, or the existence of God? Dr. Alexander makes a compelling case, but there's still room for doubt. His book has received lots of attention in the media, with predictably mixed reviews. For me it was an absorbing and provocative read, so I recommend it to you on that basis. I think you'll find that much of what he says is consistent with truths we come to in our Quaker practice, but my question is, "Does it speak to you?" I invite you to share your reaction with our Friendly community.

A Graduation To Be Proud Of - from Nina Berry et al

On April 5th, Friends from the Meeting had the honor of joining with Moses Brown School parents and staff to attend a very special graduation ceremony. The fifth grade class is the first group of children to graduate from the Nonviolence Training program, taught by The Institute for the Study & Practice of Nonviolence.

The course was initially designed to teach the principles and practices of nonviolent conflict resolution to police officers, inmates and community members. Teny Gross, the Executive Director of the Institute, gave an introduction to the nonviolence program and Sal Monteiro, the organization's nonviolence coordinator, explained the training work done with the students. The students met three times each week during the semester with Mr. Monteiro to learn conflict resolution techniques adapted from Martin Luther King. Jr. Students demonstrated their learning in several role-playing presentations as part of the ceremony; they included how to work as a community, and how to act in response to limited resources. Each student received a certificate from Executive Director Gross, all signed by Providence Mayor Angel Tavares.

The training is considered to be important at this Quaker school, where students at all levels are taught to respect and honor the unique light inside each individual and to find meaningful, non-violent resolutions to conflict. Moses Brown teachers believe that these values, and programs such as the Non-Violent Training, are critical to developing 21st century skills in students, including creativity, critical thinking, problem-solving, decision-making, communication, collaboration, citizenship and social responsibility.

The Institute was founded in 2001 with a mission to "foster a community that addresses potentially violent situations with nonviolent solutions". To learn more, visit *nonviolenceinstitute.org*.

Help RI Say No To Citizens United

(from a Sierra Club note)

Rhode Island is the first state in the country to consider amending the state constitution in response to the controversial US Supreme Court "Citizen's United" ruling. The Sierra Club note calls it a way "to say that corporations aren't people and money isn't speech." A petition to support amending the RI Constitution has been started, reading in part:

"We, the People of Rhode Island, reject the U.S. Supreme Court's Citizens United ruling and other related cases, and move to amend our state Constitution to firmly establish that money is not speech, and that human beings, not corporations, are persons entitled to constitutional rights."
