### Providence Monthly Meeting for Worship with a Concern for Business Minutes – 12 Tenth Month, 2014

1. We gathered at Saylesville meetinghouse at 12:00 noon, with fourteen present. In the opening worship, the clerk read an Advice from *NEYM Faith and Practice* (Interim printing, 2014):

Speak with your own voice, using terms true to your experience. Offer the message you are given in simplicity and sincerity, dispensing with preamble, apology, or justification.

### 2. Announcements:

A memorial service for our member William Ruggiero will take place at 2:00 pm on the 18<sup>th</sup> of this month at the Saylesville meetinghouse. Although the service is being held at Saylesville, this is a meeting-wide activity, so all Providence Monthly Meeting members and attenders are invited.

Rhode Island-Smithfield Quarterly Meeting will be held on the 19<sup>th</sup> of this month at the Smithfield meetinghouse, beginning with Meeting for Worship at 10:30 am. All are welcome to attend.

3. Correspondence: A RI Interfaith Power & Light conference entitled "Interfaith Action on Climate Change," with a speech by Sen. Sheldon Whitehouse, will take place on the 15<sup>th</sup> of this month, from 8:30 am to 11:30 am, at Gloria Dei Lutheran Church, 15 Hayes Street, Providence (across from the Providence Place parking garage). There is a \$15 registration fee.

4. On behalf of Ministry and Counsel, Kathi Lyons brought the following recommendations:

Jules Burrowes has requested membership in the meeting. She was born into membership in Philadelphia Yearly Meeting, but her membership records have apparently been lost or lapsed so this is not formally a transfer. We approve this recommendation, and ask Kathi Lyons to coordinate a welcome for Jules, probably at our next regularly scheduled potluck.

Ministry and Counsel has been considering the question of an Assistant Presiding Clerk, who according to our practice may succeed to the position of Presiding Clerk. They bring forward the name of Abigail Mansfield Marcaccio, who has agreed to serve. We approve this appointment, effective immediately.

Ministry and Counsel has noted that the Funeral and Burial Grounds Committee is currently short-handed, and that it would be useful to have another member of Ministry and Counsel on it. Kathi Lyons has agreed to serve in this role. We approve this appointment.

5. For Finance Committee, Mike Hirtle noted that our meeting handbook calls for an annual "audit" of the meeting's books. This has not been done in quite a few years. The Finance Committee believes it would be good practice to resume doing annual reviews, though not a full audit in the legal sense. We concur with that policy. Matt Hackman has already been appointed to serve; it was felt that a second auditor/reviewer should be added who is not currently a member of the Finance Committee. Bruce Carlsten is willing to serve and has the needed skills. We approve this appointment.

6. For Peace and Social Concerns Committee, Mark Conley brought a concern about our relationship with RI Interfaith Power & Light. In 2008 we took steps to join RI-IPL (see minute 4th mo. 2008 # 10), but have not recently been active or paid dues. Peace and Social Concerns recommends that the meeting renew its active participation in RI-IPL, by paying the annual dues, and re-engaging with RI-IPL's mission and work. For this year, Peace and Social Concerns requests that the dues of \$50 be paid from the discretionary fund, with the expectation that in future budgets it would be a recognized line. We approve this expenditure and concur with Peace and Social Concerns' proposal to re-engage the meeting with this work.

### Providence Monthly Meeting for Business Minutes (cont. from p2)

7. Finance Committee Report: Mike Hirtle noted that the budget cycle for next year begins shortly; he will be contacting committees. The committee anticipates sending an appeal letter soon to our mailing list.

Following up on the request from the NEYM Pooled Funds for advice on its social investment policy, the Finance Committee reached unity on the following minute:

There appeared to be consensus that the Board of Managers should move to divest from fossil fuel related investments, but that such divestment should take place in an orderly manner such that adverse economic impacts to the Pooled Funds are minimized. In addition, the Board of Managers should seek alternative energy investments that do not involve fossil fuels or contribute to global warming.

The Finance Committee feels that this minute should properly come from the meeting as a whole. It will be held over to give Friends an opportunity to review and season it.

Mike also presented, for information, a "Global Investor Statement on Climate Change" signed by several hundred fund managers and organizations. The Finance Committee would like the meeting to consider asking NEYM to join as a signatory to this policy statement. It will be brought back for consideration after Friends have had an opportunity to read it in full (text at http://investorsonclimatechange.org/).

8. Ministry and Counsel report: The committee reports that it has expended \$1,500, from the Deborah Jenks Fund and the committee's discretionary line, to support our member Hannah Monroe's work this year with Quaker Voluntary Service in Atlanta, Georgia.

9. Saylesville Friends ask that we hold Joanne Griffin in the Light as she is experiencing some health challenges.

10. No further business appearing, we adjourned at 1:10 pm, intending to meet next on the 9th of 11th month at Providence meetinghouse.

We have landed in Chicago and are happily in the process of settling in. Greta is doing well at a regional school for gifted students, including riding the bus! Jordan is very excited to be an artist in residence at Theater Gates Studios.

We are requesting a small but specific act of assistance. For people facing difficult times, Quakers have a tradition of "Holding in the Light" those individuals and their concerns. In whatever manner suits you, we are requesting that you hold Mariana in the Light, or, in other words, that you keep her in your thoughts.

### CLERK'S CORNER by Dan Lederer

### The Value of Kindness

Life is either a daring adventure or nothing. Helen Keller

My religion is very simple. My religion is kindness. Dalai Lama

NYC graphic artist R. J. Palacio's first novel will provide an entirely new perspective for many readers. It's a children's book entitled "Wonder", which you may have heard of since it's received a lot of press and has spent many weeks on the New York Times Best Seller list. This is somewhat surprising since it's aimed at middle schoolers, with the story narrated by several fifth graders, kids in the 10 to 11 year old range. Despite this focus on youngsters, once you start reading it you realize that the author's message, while certainly appropriate for children of that age, also has much to say to adults of any age.

The title was inspired by the Natalie Merchant song "Wonder", which begins with:

Doctors have come from distant cities Just to see me Stand over my bed Disbelieving what they're seeing

They say I must be one of the wonders Of god's own creation And as far as they can see they can offer No explanation.

The story is about a boy named August, born with a congenital facial disfiguration that's severe enough to shock anyone who sees him for the first time. His parents, in an effort to protect him from teasing and bullying, have home schooled him up until the point when the narrative begins, as he and they contemplate enrolling him in a private school. He decides to have a go at it, and the book then chronicles the ups and downs of his time in the fifth grade, during which he, his classmates, and his teachers learn about the nature of courage, the meaning of friendship, and the value of kindness. The book delivers a message that should appeal to Quakers, specifically that, no matter how different others may seem and even how frightening they may appear, we all come from the same Source and are, in the spiritual sense, brothers and sisters.

"Wonder" is a work of fiction, so the events it describes didn't actually happen, but the underlying truths in it are real. For me, reading this book was an uplifting experience, and I would predict it will be the same for you. Some of it may make you cry, but it will leave you with a smile. If you decide to read it, and I hope you do, please let me and other Friends know your reaction. I think it could be the basis for a lively and useful conversation.
