# Providence Monthly Meeting for Worship with a Concern for Business Minutes – 13<sup>th</sup> Ninth Month, 2015

1. We gathered at 12:01 pm at the Saylesville meetinghouse, with thirteen present. In the opening worship the clerk read the following queries, from the Faith & Practice (2002) of Philadelphia Yearly Meeting:

Is our meeting for business held in the spirit of a meeting for worship in which we seek divine guidance? Are we careful to keep in the spirit of worship each of the concerns that emerge, whether of nurture, of Spirit, of social concerns, of property, or of finance?

- 2. Announcement: Rhode Island-Smithfield Quarterly Meeting will take place at the Providence meetinghouse on Sunday, October 18 after Meeting for Worship and a potluck lunch. There will be representatives from Westerly, Worcester, and Smithfield Meetings. The program will be a discussion of the meaning of this year's theme at New England Yearly Meeting sessions, "Living Into Covenant Community." All are welcome to join us.
- 3. Use of meetinghouse: For the Program Committee, Nina Berry brought a proposal that the third floor room in the Providence meetinghouse be available as a part-time office for the American Friends Service Committee staff person, Martha Yager. The room would still be available for its current uses by meeting committees, youth retreats, etc. AFSC has offered \$200 a month as rent, which seems more than adequate to cover any additional expenses. It was clarified that Property Committee has authority to purchase a small air conditioner if needed.

We approve this proposal, leaving the details to be negotiated between the Program Committee and AFSC, with the final agreement being executed by the meeting Clerk on our behalf.

4. Membership recorders' report: Ann DiMase presented a report on behalf of herself and Elsie Morse. She explained that they have a regular pattern of contacting nonresident members, resident members who have become inactive, and junior members who have reached full membership age. She enjoys receiving responses to these letters.

She noted that our member Gerald Meyers is deceased. She also reported that Michael DiMascio and Nancy Stevenson, formerly active in the Saylesville preparative meeting, have asked to be released from membership. We approve their request.

- 5. Treasurer's Report: Treasurer Peter Swaszek presented his report on meeting income and expenses for the first quarter of the fiscal year. He noted that we received a bequest of approximately \$50,000 from our member William Ruggiero, restricted by the terms of the will "to be used for the maintenance and upkeep of the Saylesville Meeting House." Income for use of the Providence meetinghouse continues to increase, enabling us to put money aside for needed maintenance and upgrades.
- 6. Finance Committee: Mike Hirtle, Finance Committee Clerk, drew our attention to the maintenance fund for Providence meetinghouse. In the past few years, the amount spent on maintenance has used the annual allocation to this fund. This spending has included upgrades such as redoing all the doors with proper panic hardware. The Finance Committee will be consulting with Property Committee to discuss planning for future needs.
- 7. Saylesville: Joanne Griffin reported that those worshipping at Saylesville look forward to meeting later this month with members of Ministry & Counsel. Activity has picked up for the fall, including singing after the rise of meeting on October 25. She noted that a car recently damaged the front fence, providing an opportunity to repair and repaint the entire fence.
- 8. Other concerns: The Clerk invited those gathered to bring forward any concerns that should be brought to the attention of one of our committees. None appearing, we closed with a few minutes of worship at about 1:00 pm, intending to meet next on the 11th of 10th month at the Saylesville meetinghouse.

Emails sent to this address go out to ALL subscribers. It's up to you to determine whether the message is of interest to Friends and whether it's sufficiently edited and formatted for all to understand.

Links are acceptable in the text of a message, but to reduce the risk of viruses, attachments are generally discouraged (with the exception of things we compose ourselves, such as the Meeting newsletter). If an attachment is essential and you are confident about its origin, you can send your email message with attachment to the list moderator at <a href="list@providencefriends.org">list@providencefriends.org</a> for distribution to all subscribers.

To avoid garbled formatting, either type your message directly into an email, or paste it into the email from a standard word processing program. If formatting issues persist, try first pasting as plain text in the email and then adjusting. Simple formatting often works best, and hard returns between paragraphs are easier to read than blocks of text.

When responding to a message on the email list, please reply only to the sender of the message rather than to the whole group. This may require you to edit the email address in the "To" field.

## A Note of Thanks from Hannah Monroe, QVS Volunteer

Hannah Monroe has returned from her year with Quaker Voluntary Service. She sent this letter to the meeting after her return.

Dear Friend,

For my QVS year I lived in Atlanta and was an intern at Atlanta Legal Aid Society with their Disability Integration Project. My spirituality and my views about social justice have been shaped by growing up in New England Yearly Meeting, and my work this year has helped me continue to grow spiritually and as an activist. It was wonderful to have this opportunity to learn more about disability rights, including connections to my other interests, and I will incorporate that into my graduate school work. This was an especially good year for me to work in disability rights because this year was the 25th anniversary of the Americans with Disabilities Act. I had the opportunity to help plan a parade to commemorate that and was able to attend the annual Society for Disability Studies conference.

I've also grown spiritually, spending a significant amount of time reflecting on what kind of person I would like to be in the world, especially through my work. I've been learning about Buddhist philosophies and have been incorporating these ideas into my Quaker spirituality. I'm looking forward to how this will affect my perspective on my academic and activist work in graduate school, since research around social justice, animals, and the environment is the work I feel spiritually called to do.

Additionally, my experiences this year gave me insight into gifts I was not previously aware of. My work involved listening to people's stories and I've now realized that counseling is something I might like to pursue as a career. I wouldn't have known that if I hadn't had this experience. This skill will also help me in academia and throughout my life. The opportunity to discover and practice new skills, as well as explore new and different ideas, is a wonderful aspect of Quaker Voluntary Service.

I really enjoyed the opportunity to live in Atlanta this year and get to know this city. I found great community here through Quaker Voluntary Service as well as the LGBTQ and vegan communities in Atlanta. I made many friends here and will keep in touch with them when I go to graduate school next year. Taking this year to have different experiences has helped broaden my awareness of the world and myself. Thank you for the support in making this work possible!

#### **CLERK'S CORNER** by Dan Lederer

#### The Death Penalty

In federal court on May 15, 2015, Dzhokhar Tsarnaev received a death sentence for the 2013 Boston Marathon bombings. The appeals process may take years as he lingers on death row.

Froma Harrop, in her Providence Journal column 5 days later, suggested that it was curious that he was sentenced to die in a state where a recent poll had shown that only 19% of respondents favored his being put to death, one reason being reluctance to elevate his status to that of a martyr. She pointed out that there is widespread opposition to the death penalty in states beyond Massachusetts, reasons including that it runs counter to pro-life philosophy and that execution of innocent persons can't be prevented entirely and of course can't be reversed.

In its newsletter, Friends Committee on National Legislation (FCNL) presents its reasons for opposition to the death penalty: "Executing criminals does not effectively address the roots of violence in our society. It has not been shown to effectively deter the sorts of crimes for which it is applied. It does not restore lives destroyed by acts of violence." And finally, "we believe that state-sanctioned killing denies the sacredness of human life and violates our belief in the human capacity for change."

I want you to hear from a Quaker couple, Amanda and Nick Wilcox, whose daughter Laura, a college sophomore, was shot to death in 2001 at a California behavioral health clinic by a mentally ill client who subsequently was found not guilty by reason of insanity. There were cries in the community for a death sentence, but these grieving parents steadfastly opposed it. Here's what they wrote: "As Quakers our family, including Laura, had always been opposed to the death penalty. In the immediate aftermath of the shooting, while still in disbelief and shock, we leaned on our long-held beliefs; we remain opposed to the death penalty....From a purely analytical perspective, the death penalty might be justifiable if it deterred crime and saved lives, or if it resulted in a reduction in State costs. Studies have shown that it does neither of these things. The death penalty, therefore, can only be viewed as an institutional expression of revenge and retribution. Rather than focusing on the offender, it must be asked what the death penalty says about us as a society."

In seeking our own position, we Quakers need look no further than our basic premise that there is that of God in every person. This by itself should be enough to lead us to oppose the death penalty.
