Providence Monthly Meeting for Worship with a Concern for Business 10th of Ninth Month, 2023

Minutes

Friends gathered at the Providence meetinghouse at noon with 19 present and 7 additional Friends on Zoom.

Presiding clerk Victoria Ekk began the period of silent worship by reading the following queries taken from New England Yearly Meeting's *Faith and Practice* of 2011:

Do we as a community desire to take hold of every opportunity to lessen the distresses of the afflicted?

Do we seek to turn all the treasures we possess into the channel of universal love?

Do we seek to live in affection as true Friends in our meeting, in our families, in all our dealings with others?

The clerk read this announcement: Friends will be encouraged to greet each other at the rise of Meeting for Worship in whatever manner they choose, including shaking hands.

The following items of business were brought forward:

1. Treasurer Peter Swaszek brought the report for the first quarter of the fiscal year. Income and expenses were fairly close to even and there is ample money in the bank. The expenses for Nursery and Childcare and Peace and Social Action committees are noted as having been unusually high during this quarter. He noted that the temporary fund created for the visit of the Golden Rule ship is still shown in the report pending confirmation that all expenses from the visit have been met. We received the Treasurer's report with thanks.

- 5. Ministry and Counsel Committee reported that Presiding Clerk Victoria Ekk will be moving away from Rhode Island and recommended that Ariana Steele be chosen as the new Presiding Clerk and Jules Burrowes as Assistant Presiding Clerk for Providence Monthly Meeting, effective at the close of this business meeting. Friends approved, with expressions of gratitude for all who serve our Meeting.

No further business appearing, we closed with a period of silent worship at 12:45 p.m., intending to meet next on the eighth of Tenth month at the Providence meetinghouse.

Meehan/Hagen Wedding September 18



Messages at Meeting for Worship

An interesting feature of Friends' manner of worship is that, especially in regard to messages, one never knows what will take place. One of our brochures introduces the topic of messages as follows:

In our unprogrammed Meeting for Worship, vocal ministry takes the form of spoken messages. The spoken word has always had an important place in bearing witness to the faith of Quakers. Vocal messages can be as effective in a few halting but spiritually filled words as in the most learned and articulate message. In vocal prayer even broken and imperfect words springing from a deep place in the heart may wonderfully draw those present into communion with God and with one another.

We ask that Friends come to Meeting for Worship neither intending to speak nor intending not to speak. So even though we encourage spontaneity, we also urge Friends to be mindful of the following guidelines:

- We try to listen for that still, small voice within that can lead us to speak, and act, in ways that benefit our Meeting community.
- We ask that messages be suitable for the group, and that language be respectful of
 everyone in attendance, without the use of derogatory or offensive words, even though some
 of these may be heard commonly outside of Meeting.
- We encourage messages that are simple, clear, and brief, and ask Friends to speak only
 once. Messages ought not be seen as an opportunity to announce upcoming events or
 promote political or social action agendas. Also, Meeting for Worship is not the place for
 discussions, debates, arguments, or lectures.
- Finally, we ask Friends to stand and speak loudly enough so that all can hear, and to allow a
 period of time between messages to reflect on what has been said.

I think most of us who have attended Meeting for Worship over the years have found that the messages expressed there have often been sources of inspiration and comfort. I hope we will each find ways to do what we can to strengthen our Meeting and preserve our unique manner of worship.

Clerk's Corner: Looking Back at the Clerkship

Yesterday, while reorganizing my electronic files, I found my first Clerk's Corner letter, dated September 16, 2021. In it I had included a graphic of Rhode Island with the Hope symbol in the center. That was my view forward as everyone, including our Meeting, waded through the COVID 19 pandemic. While COVID is still with us—I had my fourth bout in July—we are well into a more "normalized" way of living, and I am personally transitioning out of the PMM clerkship as I prepare to move to Oregon.

Being Clerk is not easy. As Clerk, I tried to be a facilitator, a listener, and a collaborator with committee clerks and members/attenders. It's not what the Clerk wants for PMM but how they assist Friends to discern what the community is being led to do. Sometimes we got there and we achieved what we set out to do, and sometimes we only got part of it accomplished, or maybe we learned that we are not there yet. Not to worry, because we are only called to be open to the Truth that we see and do our best until we come to the next point in our pathway.

What are my impressions as I look back to that start in 2021? I can tell you that I experienced a rollercoaster of emotions as I carried out the day to day work of the Meeting. I worried, problem solved, discussed, agreed, disagreed and mediated trying to keep Hope foremost in every small and large crisis. Most importantly, I learned so much!!! I rediscovered that most times what I feared would happen did *not* happen, or that the negative effects were much milder than my dark expectations. For example, we struggled to come to agreement on online worship, but we found a way for folks who are unable to come to agreement on online worship, but we found a way for folks who are unable to come to Meeting for Worship in person to join those in the meetinghouse every other First Day.

I also learned that our fortune is in our community. I gained so much by getting to know Friends well

beyond brief conversations during coffee hour. Knowing what brought them to Meeting, their areas of interest, and family circumstances enriched my appreciation of our community. And while we sadly lost several of our veteran Friends, we gained several new young families!

I learned to make peace with the fact that change is inevitable and that flexibility and a good sense of humor are essential! Sometimes we take ourselves so seriously that we forget what it takes to make good community decisions. Last week in a Zoom meeting, Friend Benigno Sanchez Eppler provided queries to assist in discernment: "What does Love ask me to do?" "What does Love ask us to do?" Answering those queries with positive action, and acting on hope and love is bound to provide good results!
